The scholarship was established in 1991 in honor of former manager Gilbert Hilkemeyer to provide assistance to students within our service area who want to attend college or learn a skill in a vocational institution.

This is a **\$1,000** scholarship which will be awarded to one deserving student. A three-person committee will look over all applications, interview the finalists and then choose the scholarship recipient based on the interview, grade point average, ACT scores, school, church and community activities, and letters of recommendation.

The scholarship is available to high school seniors whose parents or guardians are members of Three Rivers Electric Cooperative.
